

## GENERAL CONDITIONS OF SALE

*APPLICABLE TO THE 10<sup>TH</sup> BONDY ARCHERY TOURNAMENT  
WEEKEND OF JANUARY 6 AND 7 2024*

### ARTICLE 1: SCOPE

THESE GENERAL CONDITIONS OF SALE APPLY, WITHOUT RESTRICTION OR RESERVATION, TO REGISTRATIONS FOR THE 10TH BONDY ARCHERY TOURNAMENT.

CONSEQUENTLY, AT THE TIME OF REGISTRATION, THE ARCHER OR THE REGISTRATION MANAGER ACKNOWLEDGES HAVING READ THE SPECIFIC CONDITIONS OF SALE SET OUT BELOW, THE MANDATE, THE REGULATIONS APPLICABLE DURING THE TOURNAMENT AND EXPRESSLY DECLARES TO ACCEPT THEM WITHOUT RESERVATION.

UNLESS PROVEN OTHERWISE, THE DATA RECORDED BY **AS BONDY TIR À L'ARC** CONSTITUTES PROOF OF ALL TRANSACTIONS.

### ARTICLE 2: PRODUCTS

THE SERVICES COVERED ARE:

- ARCHER REGISTRATION, INCLUDING PARTICIPATION IN THE INDIVIDUAL TOURNAMENT, THE TEAM TOURNAMENT AND THE "LUCKY LOSER TOURNAMENT" ACCORDING TO THE RULES DEFINED IN THE MANDATE;
- SATURDAY AND/OR SUNDAY MORNING BREAKFAST PRE-ORDERS

### ARTICLE 3: REGISTRATION

THIS EMAIL ALLOWS **AS BONDY TIR À L'ARC** TO SEND VARIOUS INFORMATION REGARDING THE TOURNAMENT, IN PARTICULAR THE RESULTS OR ANY OTHER INFORMATION. **AS BONDY TIR À L'ARC** WILL THEREFORE NOT BE HELD RESPONSIBLE FOR THE NON-TRANSMISSION OF QUALIFICATION RESULTS IF THE EMAIL ADDRESS PROVIDED IS INCORRECT OR IS NOT THAT OF THE REGISTERED ARCHER.

FOR INTERNATIONAL ARCHERS, PROOF OF NATIONAL FEDERATION REGISTRATION WILL BE REQUESTED TO CONFIRM THE INFORMATION PROVIDED DURING REGISTRATION.

THE TOURNAMENT RESERVES THE RIGHT, IN ITS SOLE DISCRETION, TO REFUSE REGISTRATION AND/OR ENTRY TO THE TOURNAMENT OR TOURNAMENT FACILITIES TO ANY INDIVIDUAL BASED ON PAST BEHAVIOR OR BEHAVIOR DURING THE TOURNAMENT THAT WOULD BE CONSIDERED INAPPROPRIATE BY THE TOURNAMENT ORGANIZATION.

- BETWEEN DECEMBER 4, 2023 AND DECEMBER 17, 2023 11:59 P.M. CET, ANY REGISTRATION CANCELED BY THE CUSTOMER, FOR WHATEVER REASON, WILL BE REFUNDED UP TO 50% (EXCLUDING MANAGEMENT FEES).
- BETWEEN DECEMBER 18, 2023 AND DECEMBER 31, 2023 11:59 P.M. CET, REGISTRATIONS CANCELED BY THE CUSTOMER WILL ONLY BE REFUNDED WITH PRODUCTION OF A DOCTOR CERTIFICATE (EXCLUDING MANAGEMENT FEES).
- FROM JANUARY 1, 2024 12:00 A.M. CET, NO REFUND WILL BE MADE EXCEPT IN CASES OF FORCE MAJEURE (SEE ARTICLE 7)

IN THE CASE OF A TOTAL OR PARTIAL REFUND (EXCLUDING MANAGEMENT FEES), ONLY THE PRODUCTS MENTIONED IN ARTICLE 2 WILL BE AFFECTED BY IT.

## **ARTICLE 7: FORCE MAJEURE**

FORCE MAJEURE IS AN EVENT THAT FULFILLS THE FOLLOWING 3 CHARACTERISTICS:

1. IT IS UNPREDICTABLE
2. IT IS INSURMOUNTABLE
3. IT IS BEYOND THE CONTROL OF THOSE AFFECTED.

THE FOLLOWING WILL BE CONSIDERED AS FORCE MAJEURE: A NATURAL DISASTER, AN EXCEPTIONAL CLIMATIC EVENT, FIRE AT THE PALAIS DES SPORTS, DEATH OF THE ARCHER, A PANDEMIC. ANY OTHER EVENT WILL NOT BE CONSIDERED AS SUCH.

ANY CANCELLATION IN THE EVENT OF FORCE MAJEURE, EVEN THE DAY BEFORE THE EVENT, WILL BE SUBJECT TO A FULL REFUND (EXCLUDING MANAGEMENT FEES).

## **ARTICLE 8: PUBLIC HEALTH FORMALITIES**

WE WILL FOLLOW ALL LEGAL MEASURES IN FORCE ON THE DAY OF THE EVENT.

## **ARTICLE 9: PRIZES**
